

## **Lower Columbia Chapter News**

What happens when you send out a mayday for newsletter content to our members? Well they come to the rescue! Arlan Hackett sent out a request for ideas, and we had some great input. WDFW Wildlife Manger Daren Hauswald indicated he had been using some of his stay-in-place time to capture and band Band-tail pigeons (See Story on adjacent Page 5).

Arlan Hackett suggested recapping the Black Box 3-man polymer pit blinds our chapter has purchased and donated over the years to the Ridgefield National Wildlife Refuge (NWR) and to the Shillapoo Wildlife Area. The blinds we purchased are actually 4-man blinds that we constructed cedar dog boxes for and installed on one end, as Ridgefield only allows 3 hunters at a time. These blinds are well made, easy on your guns (as opposed to the old concrete predecessors) and seal up completely between usages. This keeps the blinds relatively dry inside compared to 3-6 inches of water in the old pits (not to mention all the snakes and mice when we open them up in the fall).

That blind is now blind #12 at the **Ridgefield NWR**. Since then we have purchased six (6) more with some help from the **Ridgefield**. They have been placed as blinds #4, #18 and most recently last year #17. The two (2) remaining blinds are yet to be installed. One blind was placed at the **Shillapoo State Wildlife Area**.

The **Seattle Chapter** also has purchased two (2) actual 3-man blinds and the **Willapa NWR** has purchased one, for a total of three (3) for their **Rickola** goose unit. This totals over \$40,000 in blind donations by **WWA** to enhance waterfowl hunting on these two (2) federal refuges. A pretty significant accomplishment.

Crystal Mathews had a wealth of input and good ideas. She mentioned that May is the annual observance of American Wetlands Month. Established in 1991 by the Environmental Protection Agency, American Wetlands Month is a time when EPA, and public and private organizations celebrate the vital importance of wetlands to our nation's ecological, economic and social health. The annual recognition helps highlight the important role wetlands play in the natural ecosystem, such as helping to

## **Banding Band-Tails**

[Editor's Note:] WWA-LC Chapter member and WDFW Wildlife Area Manager Daren Hauswald has been making the most of the "Stay at Home "order by trapping and banding Band-tailed Pigeons at his backyard bird feeder, and describes the process for us.

Since the **Governor's Executive Order** was issued most **WDFW** employees have been teleworking from home as most of the field work that myself and my fellow employees typically accomplish in the spring was suspended due to the Covid 19 pandemic. Although I would rather be working out on one of the many areas we oversee, I made the most of the current situation, by still getting out into the field (er "backyard") to accomplish some wildlife management work.

The Band-tailed pigeons arrive at my feeder in late March every spring and stay until late May before moving on to other locations and food sources. Pigeons will also return in early September as they migrate back south to winter in Mexico.

The banding effort will help track migration movements, age, and harvest rates over the lifespan of the birds by people reporting the marked birds that they recover. I will also attempt to trap pigeons this fall to see if any of the marked birds return, or if perhaps the fall birds are different than the ones that come through the area in the spring.

The traps are modified mourning dove traps. So far, I have banded 43 and I am hoping to get at least 50 in total. The traps that I am using are wire cages that have a door on the top that I can close once the birds jump in.

The pigeons don't like going through the side funnels all that much and about 80% of the pigeons that I have trapped come in through the top. I have fishing line connected to the top door that I pull closed when birds are inside.

It takes me back to when I was a little kid when I would try to get birds and squirrels with a propped-up box with string connected to a stick to drop the box. Being able to get away from the virtual meetings and trainings to still have some hands-on wildlife work, while not being able to get out into the field has helped greatly in keeping me sane during these circumstances we are all in!



#### WDFW Seeks Public Input on Management Plan for Scatter Creek Wildlife Area

OLYMPIA – The Washington Department of Fish and Wildlife (WDFW) wants to hear from the community on a draft management plan for the Scatter Creek Wildlife Area located in Thurston and Grays Harbor counties. Public input is welcome through June 8.

"We greatly appreciate and value input from neighbors, partners, and visitors," said **Darric Lowery**, **Wildlife Area Manager for WDFW**. "Your feedback helps us craft a more relevant and attainable plan so we can make **WDFW**-managed lands better for both wildlife, and the community."

Consisting of six (6) separate units, the wildlife area covers about 3,601 acres and is popular for hunting, fishing, wildlife watching, horseback riding, and hunting dog training.

The wildlife area encompasses portions of unique South Puget Sound prairies and oak woodlands, as well as aquatic, forest, and wetland habitats that support a variety of wildlife species, including the federally endangered Taylor's checkerspot butterfly, and the threatened Mazama pocket gopher.

A local citizen advisory group helped develop the draft management plan, which will guide how the Department makes operations and budgeting decisions on the wildlife area for the next 10 years.

The draft management plan is undergoing a 30-day State Environmental Policy Act (SEPA) public comment period and is available on WDFW's website under "Management Planning" at <a href="https://wdfw.wa.gov/places-to-go/wildlife-areas/scatter-creek-wildlife-area">https://wdfw.wa.gov/places-to-go/wildlife-areas/scatter-creek-wildlife-area</a>.

**WDFW** staff had to cancel plans for a public meeting due to the ongoing COVID-19 pandemic, but incorporated some community input into the draft plan from a public meeting held in March 2019.

#### **Kenmore Range Opening Update (as of May 10)**

From Joe Rinaldi President, Wildlife Committee of WA, Inc.

It is with deep regret that we announce that we do not have approval by **Governor Inslee's** office to re-open the range. We are currently planning to reopen the range if we meet Phase 2 criteria as set forth by the State of Washington. If we do meet the criteria, then we will be open to the **membership only**. Check for **Kenmore** updates **here**.

The board came to this decision based on guidance from our legal counsel regarding opening the club and resuming business operations.

Among the activities authorized to restart in Phase I are:

- Recreational hunting, fishing, and boating;
- Outdoor exercise, including hiking, running, walking and biking;
- Golfing;
- Day-use activities at public parks and public lands.

The memo is very narrowly tailored toward the reopening and limited operation of golf courses. In proclamation 20-25.2 immediately following the above enumerated authorized recreational activities, the Governor clarifies/limits the scope of Phase I recreational activities as follows:

"...ADDITIONALLY, except as exempted above, I continue to prohibit all other public and private gatherings and multi-person activities for social, spiritual and recreational purposes, regardless of the number of people involved. Such activity includes, but is not limited to, community, civic, public, le...

It is infinitely clear reopening the range would not be permissible during Phase I. Proclamation 20-25.2 also provides

..."[v]iolators of this of this order may be subject to criminal penalties pursuant to RCW 43.06.220(5)."

Violation of this proclamation could therefore subject the range to a gross misdemeanor, and potential civil penalties such as fines and suspension or revocation of the range's business license.

We are disappointed and frustrated that the State's actions are creating confusion for our staff, members and customers, and we are working diligently to resolve this situation by working with entities such as the National Shooting Sports Foundation and the Washington Range Alliance. Unfortunately if we lose our business license we will not be able to operate for members or the public, hence the board has taken a conservative approach to reopening.

We are waiting for a clear proclamation from the Governor and will remain closed both to the members and public in the near term.

## **Special Hunt Permit Application Deadline Extended to May 21st**

OLYMPIA – Hunters can now submit special hunt applications through midnight Thursday, May 21 for deer, elk, mountain goat, moose, bighorn sheep, and fall turkey 2020 seasons in Washington.

"The original deadline was May 18," said Eric Gardner, WDFW Wildlife Program Director. "Unfortunately, the printed pamphlets shipment to our dealers have been behind schedule due to COVID-19 complications, so we want to give hunters a few more days to review and submit applications."

The Washington Department of Fish and Wildlife (WDFW) will conduct a random drawing to select permit winners in June. Hunters who receive special permits qualify to hunt beyond the times and places authorized by a general hunting license.

A printed version of the pamphlet is now available at dealer locations across the state, though WDFW region offices remain closed. Residents are advised to call local WDFW offices or their local license vendor to determine if they are open before making an in-person visit. The pamphlet has been available for download since April 20.

Should the Department have to cancel these hunting seasons, hunters would be entitled to a refund or point restoration.

Hunters can buy applications and licenses from license vendors statewide or on **WDFW's** website. They must submit their applications on the website or call 1-877-945-3492 toll-free.

Hunters buying and applying online must create a username and password in the Department's **WILD** system. They can find more information about creating their WILD system account. Hunters can also click the "Customer Support" link on the **WILD** homepage for additional assistance.

Most special hunt permit applications cost \$7.10 for residents, \$110.50 for non-residents, and \$3.80 for youth under 16. Resident applications for mountain goats, bighorn sheep ram, moose, and "quality" categories for deer and elk cost \$13.70.

# **WA Legislative Report**

[Editor's Note: WWA is a voting member of the Washingtonians for Wildlife Conservation (WWC). WWC is a member organization of the Hunter's Heritage Council (HHC), a Washington State based organization dedicated to political action on behalf of the hunting and related communities of Washington].

Well the legislative session ended March 12, 2020, but that doesn't mean that the **Hunters Heritage Council** (HHC) wasn't busy. I was in on all of the on-line **WDFW** closure meetings because of the Governor's shutdown order. I have heard hunters complain about **Director Kelly Susewind** having fault in this situation, and in my opinion, nothing could be further from the truth.

After **Governor Inslee** ordered the shutdown, there was still a clam dig on a Pacific beach, and a health official complained. The clam dig was shut down by the Governor as was youth turkey. Spring turkey, and spring bear were indefinitely postponed. It was probably in the best interests of all that this happened. I know that some of you won't like my comments, but I will explain my reasoning.

I think the protests may have had a little play in this, but **WDFW** took a huge hit in the pocketbook. They lost a lot in license sales. **Commissioner Kim Thornburn** told the Governor during the lockdown that it was time to open hunting and fishing up. She is a retired public health physician with considerable experience with policy development, including a short stint as chair of the **Washington State Board of Health.** Having her say that it was time to open things up gives it a lot of credibility.

The first meeting on opening things back up I wasn't all that thrilled about. Turkey hunters got nothing. Youth turkey was not rescheduled, they just lost out, and no extension on spring turkey. Spring bear hunters came out smelling like roses, they got their season extended to June 30th, and if they didn't like that they could get their points refunded or even as a last resort a money refund!

The second meeting was getting ready for the May 5th rollout — WDFW facilities won't stocked with toilet paper, and the sites won't be maintained! Hunters and fishers will need to bring in all their own supplies and pack out all of their trash. **WDFW** will be looking at fall options

for turkey incentives. The theme is hunt and fish local in your own county.

The legislative session lasts 105 days during oddnumbered years and 60 days during even-numbered years unless there are special sessions. The **WDFW Commission** meets 11 of the 12 months of the year. These nine (9) members have incredible power over our fish and wildlife policy. The **Washington State Constitution** gives the Legislature the authority to regulate wildlife policy. That policy is in **Title 77 of RCW. RCW 77.04.012** is titled "Mandate of Department and Commission." Here are the first four mandates:

- (1) Wildlife, fish, and shellfish are the property of the state. The Commission, Director, and the Department shall preserve, protect, perpetuate, and manage the wildlife and food fish, game fish, and shellfish in state waters and offshore waters.
- (2) The department shall conserve the wildlife and food fish, game fish, and shellfish resources in a manner that does not impair the resource. In a manner consistent with this goal, the department shall seek to maintain the economic well-being and stability of the fishing industry in the state. The Department shall promote orderly fisheries and shall enhance and improve recreational and commercial fishing in this state.
- (3) The Commission may authorize the taking of wildlife, food fish, game fish, and shellfish only at times or places, or in manners or quantities, as in the judgment of the commission does not impair the supply of these resources.
- (4) The Commission shall attempt to maximize the public recreational game fishing and hunting opportunities of all citizens, including juvenile, disabled, and senior citizens.

Right now, we have a great Commission! I cannot say enough good words about some of the members of our Commission. We have fought so hard to get control of the Commission with recreational hunters and fishers, and for the first time in a long time we finally have it. Both **HHC** and **WWC** work the Commission problem hard. I am all smiles with the new Commission.

Our newest Commissioner **Jim Anderson** may be the best person who has ever served on the Commission. He is one of us, an avid hunter and fisher. As the former chair of the **Northwest Indian Fisheries Commission**, he is incredibly smart, well rounded, and understands policy.

# Trapping Season in Your Own Backyard — Asian Giant Hornets

WA Department of Agriculture News Release

There has recently been national attention on Asian giant hornets that were found in Washington State. The trapping instructions below are for people who wish to participate in volunteer trapping **WITHIN** Washington State.

There are no known sightings of Asian giant hornets anywhere else in the United States and trapping for them there will likely do more harm than good by catching native desirable insects. PLEASE DO NOT TRAP FOR ASIAN GIANT HORNETS IF YOU LIVE OUTSIDE OF WASHINGTON STATE. Thank you for your interest in assisting in trapping for Asian giant hornets.

Asian giant hornets pose a serious threat to honeybees, other insects, and even humans. By participating in trapping, you can help limit the spread and possibly even eradicate Asian giant hornets from Washington State. Although we invite anyone in Washington to participate in trapping, we are particularly interested in volunteer trapping in Whatcom, Skagit, Island, San Juan, Jefferson, and Clallam counties.

#### **WARNING**

Asian giant hornets pose a <u>risk to human health</u>. While they do not generally bother humans, they will attack if they feel threatened. Participating in Asian giant hornet trapping could increase your risk of being stung by Asian giant hornets. Be sure to seek immediate medical attention if you have a reaction or are stung multiple times. Should you locate a suspected Asian giant

hornet nest, **DO NOT** approach or attempt to remove it. Note the location and report it to **WSDA** immediately. If you are allergic to bee or wasp stings, you should NOT engage in trapping for Asian giant hornets.

#### TRAPPING - IT'S A COMMITMENT

In order for trapping to be successful, those who participate should know that trapping is a commitment. It will require you to:

- obtain materials to build and maintaining traps
- log your traps on WSDA's online mapping system
- check your traps weekly for 17 weeks starting in July and into the fall
- photograph all specimens and submit photos and any collected bee, wasp, or hornet specimens to **WSDA**.

The full instructions are below, but you can also **download** a printable pdf with the bottle trap instructions.

#### **BOTTLE TRAPS**

The trap in these instructions is known as a "bottle trap" and targets Asian giant hornet workers in the summer and fall. It may also catch Asian giant hornet queens in the spring and fall. This is the same trap used by the hornet program in Nagoya, Japan.

**WSDA** asks that participants set traps at the beginning of July and keep them up through October.

#### **EQUIPMENT**

Below are the materials you will need for one trap for an entire season of trapping from July through October (17 weeks.)





- 2 liter or 64 ounce plastic bottle
- Box cutter
- String or twine
- Orange juice (100 % with few additives) 17 4-ounce juice boxes
- Rice cooking wine (10-25% alcohol content) 64 ounces or 3 25-ounce bottles
- 5 x 6 x 2 inch storage container plastic strainer

### (Trapping Asian Giant Hornets Continued)

#### PREPARE THE BOTTLE

- (1) and (2) Near the top of the bottle make 2 cm (0.78 inch) long "H" marks on three sides
- (2) Using a box cutter or exacto knife, very carefully cut along the "H" marks.

Carefully fold the top tabs in and the bottom tabs out.

#### PREPARE THE BAIT

(3) Rice cooking wine will discourage honey bees from visiting the trap. Ensure that the alcohol content is between 10% and 25% by volume. Use 4 ounces (1/2 cup) of rice wine.

Use 4 ounces (1/2 cup) of 100% real orange juice. 4.2 ounce juice boxes are perfect and have a long shelf life. Pour the rice cooking wine and orange juice into the bottle and replace the cap.

#### **SELECT A SITE**

Hang the bottle at least 6 feet high on trees near forest edges. Do not hang bottles higher than 9 feet.

If hanging more than one trap, traps should be at least 50 feet apart.

(4) Affix a sturdy string or wire around the neck of the bottle. Hang the trap so the closed side of the bottle faces the tree.

Only place traps on your own property or property that you have permission to access.

Trap hanging tips

- Pick a sturdy branch;
- Tie a second string around the body of the trap and tree to secure the trap.

#### **REPORT TRAP LOCATION**

Visit WSDA's Hornet Watch Trap Submission Map to log the location of your trap(s). GO TO THE MAP

Report your trap location:

- Follow the instructions on the map
- Record your trap number(s) for your reference and write the number on the trap
- Create a new marker/pin for each trap

#### SERVICING THE TRAPS

Please note: If you find a live Asian giant hornet in your trap when you check it - do not handle the trap. Contact WSDA immediately at 1-800-443-6684.

Every week, collect a sample and replace the bait. This should be 17 services.

Bait should be replaced every week even if no specimens are captured.

(5) Pour trap contents into the plastic strainer. **Tip:** Pour with the closed side of trap down.

Empty the contents of the strainer into a storage container. Gently tap the strainer over the storage container to dislodge any specimens.

#### PREPARING THE SAMPLE

Place specimens in zipper bag with paper towel that has been soaked with isopropyl alcohol. PLEASE RETURN ALL **SPECIMENS EACH WEEK** - this includes both Asian giant hornets and anything else caught in the trap.

Write the trap number and collection date on the bag AND on a paper tag in the bag. **NOTE:** Isopropyl alcohol dissolves ink from pens and Sharpies. To ensure your sample is counted use a **PENCIL** to write on a piece of paper. Every week you should have specimens to send to WSDA, even if there are no Asian giant hornets.

# **RRGC Wood Duck Box Program**

Please find pasted below an e-mail ail received yesterday from **Richland Rod & Gun Club** with another Wood Duck Box Camera.

The **WWA** system that we are using will tell us if you opened the e-mail and also if you clicked on and opened the link. From this, we know that these e-mails are of high interest to the WWA Group.

If you are hunkered down at home, this may give you something to watch. If you do not have an interest, please just humor us and delete it. This is a group e-mail, and it goes out to all in the system.

We hope you are all well, and please stay safe.

In case you missed the live jump, here is a recording of the jump from box 367 on Mothers Day, May 10th at about 8:50 a.m. Twenty-one (21) ducklings jump from the box and two struggled needing assistance. The landowner has attempted to reunite the ducklings with the hen and siblings once the last one was removed from the box.

The hen in this box has band 1146-22680 that was originally captured on 4-19-2015 in box G64, just across the river. She was recaptured in 2016 in G64 but did not capture her in 2017. In 2018 she discovered box 367 and has been nesting in this box last year and again this year.

Last year we deployed a geo-locator on a tarsal band on this hen. When we recaptured her this year we downloaded the data from the geo-locator. Jason Fidorra, our district Wildlife Biologist, has analyzed the data and indicated she is a local duck, not migrating during winter. We will be exploring how to make the data available on our web page so that you can visualize her movements.

Thanks to our landowner for supplying power and wifi service for our live stream!!!

There should be additional boxes close to hatching so watch for activity on our other broadcast channels.

#### Some Recent History of the RRGC Nesting Box Program

We have accomplished performing the annual maintenance of all 474 nesting boxes that were available for wood ducks last nesting season. We have replaced some of those boxes that have reached the end of their life with boxes built by youth at the Sportsman Show or Kids Duck Day, and by students at Libby Middle School or Homeschool students.

The data collected during the effort shows 56.5 % of boxes were used by wood ducks, 86 boxes were used by Western Screech Owls, cooperative banding with **WDFW** installed 17 new bands on owls and had 24 owls recaptured having been banded in previous years.

There were 186 nest boxes that had successful hatching of ducklings evidenced by us counting 1214 membranes. We believe this number is a very conservative estimate of the actual number of ducklings that were hatched and jumped from the nest boxes. The reason we feel the number is lower than actual is because many membranes are "lost" between the hatch and when the box cleaning is performed months later.

Now that all the boxes are ready for hens, we will start to survey boxes for banding efforts. A few selected checks indicate the early nesting activities have started.

One box checked on 3-22-20 we found and recaptured a hen sitting on 10 eggs. This hen is a banded hen that has returned to this same box or adjacent boxes since 2016 when she was first banded. Additionally we had deployed a geo-locator on this hen last year on 4-23-19. Her nest hatched out and jumped from the box on 5-19-19.

Apparently the ducklings perished and she re-nested in the same nest box which jumped on 7-15-19. The geo-locator has been recovered/removed to download the mini data logger data and we will report on the migration data after the data is processed and analyzed. We are hopeful that we will recover more of the 16 geo-locators that were deployed last spring when we get further into the nesting season.



#### TREASURER'S REPORT




